What does PSCI do?

This includes defining common supplier assessment tools such as audit frameworks. PSCI carries out audits and promotes audit sharing to enhance efficiency and drive continuous improvement.

What is the purpose of PSCI audits?

PSCI audits assess a supplier's performance against the PSCI Principles as well as international standards and agreements, and local regulatory requirements. PSCI aims to ensure that its auditing model and tools become the industry norm.

Why participate in shared audits?

The PSCI Shared Audit Program allows supplier audits to be shared among PSCI members via a web-based platform. This means fewer audits for each supplier, resulting in greater efficiency for both suppliers and members. Shared audits offer greater visibility of patterns, trends and areas for improvements within the supply chain.
