WHY OCCUPATIONAL HEALTH AND SAFETY?

With growing industrialisation and the transport of goods across the globe, work related injuries, ill health and fatality is one of the greatest challenges facing us today. In 2016/2017 in the UK alone, an estimated 31.2 million working days were lost due to work related illness and workplace injury. This equates to an estimated cost of GBP 14.9 billion per year.

Industry faces the challenge understanding and prioritizing the Occupational, Health and Safety hazards and risks present in the business processes. It has long been felt that an internationally acceptable standard to systematically manage the hazards and risks and to improve performance has been required. The International Organization for Standardization (ISO) has adopted various existing Health and Safety standards (such as BS OHSAS 18001) and published ISO 45001 in 2018, which specifies the requirements for a management system to protect against and reduce the likelihood of the occurrence of risks.

SOLUTION

It is essential that all managerial and non-managerial staff are made fully aware of the hazards in the workplace and the risks arising out of these hazards to the safety of employees as well to the organisation and of the methods to control them. It is also important that all employees are made fully aware of the applicable laws in their country and their provisions as applicable to their area of operation and of the consequences of not complying with these requirements. Formal training of employees is a positive step in this direction.

THE AIM

The aim of this course is to provide delegates with the knowledge and skills required to perform first, second and third-party audits of Occupational Health & Safety management systems against ISO 45001, in accordance with ISO 19011 or ISO 17021, as applicable. All references in this document to ISO standards are to the current versions unless stated otherwise.

Delegates who successfully complete this CQI and IRCA Certified ISO 45001 Lead Auditor (OHSAS) Training course (within three years prior to applying to become a certified auditor) will satisfy the training requirements for initial certification as a CQI-IRCA Certified OH&SMS auditor.

WHO CAN ATTEND

All those who are responsible for implementing, maintaining and improving an OH&SMS according to the ISO 45001:2018 Standard must attend this course.

The course is certified by CQI-IRCA.

PREREQUISITES

Recommended prior knowledge: Delegates must have successfully completed a CQI-IRCA Certified Lead Auditor Training Course (40 hrs) on any subject with Annex SL Framework based ISO Standards. Additionally, they are recommended to undergo a Foundation training course on OHSMS (FD127 OHSMS ISO 45001:2018 Foundation).

Alternatively, delegates are expected to acquire adequate knowledge on the following:

- Familiarity with the requirements of ISO 45001
- Be conversant with the Occupational Health and Safety Management System elements and concepts
- The purpose and benefits of Hazard identification and risk assessment
- The principles of risk assessment and of managing them
- Typical OH&S strategies
- OHSMS performance metrics, monitoring, measurement and improvement methodologies

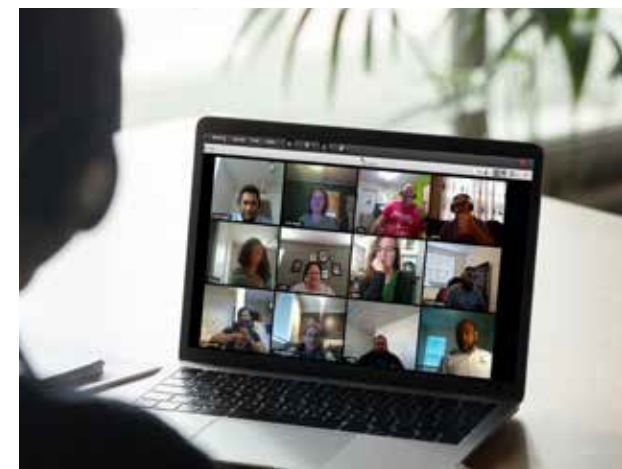
