INTRODUCTION

THE ISO 9001:2015 STANDARD WAS RELEASED ON 23rd SEPTEMBER 2015.



The newly introduced changes to the requirements of the standard are set to change the way organisations have managed their systems until now. Bureau Veritas has been a pioneer in identifying the changes, interpreting them and training the industry.

The practical exercises have been carefully designed to focus on issues that commonly arise during Quality management system audits. The Course has been updated with auditing practices as per ISO 19011:2018.




